  - b. Exact size, location, and dimensions of existing or proposed structure(s) or of proposed alteration, if any.
  - c. Traffic access and parking
  - d. Written evidence of compliance with EPA and Health Department regarding sanitary sewer requirements.
  - e. Purpose use of all parts of the lot or parcel, and structures, including accessways, walks, off-street parking, and loading spaces, as well as landscaping.
  - f. Any additional information as required by the Zoning Inspector.
  - g. The relationship of the proposed development to the Development Standards.
  - h. The use of land and location of structures on adjacent property.
  - Landscape plans, if any is to be done.
  - j. Drawings and dimensions of any signs to be erected.
  - k. Notarized statement granting permission from land owner, if applicant leases specified property.
  - l. If the proposed district is a planned district, then the application shall include the additional information required in the planned unit section of the zoning resolution.
